# Welcome to Juju!

Welcome to Juju, our social gaming application that allows users to play social games while connecting with new friends on the Juju Platform. The Juju platform includes the Juju mobile application, website (the "Site"), and services, features, content, applications and widgets offered on the Juju Platform and Site (together, we'll call these the "Services"). Juju refers to the games, as well as all of the features and functions we make available to you in the online Juju environment, including, but not limited to, all of the content, features, functions and information you may learn during the course of your experience with us online. The Services are provided by 9 Count Inc. ("Juju" or "we"). The term "you" or "User" refers to the person or entity accessing or otherwise using our Services.

These Terms of Service (or "Terms" for short) describe the rules of Juju's relationship with you and apply to your use of the Services. They are a legal agreement, so please read them carefully.

By registering for and/or using the Services in any manner, including but not limited to by uploading your profile photo and selecting your display name, and user name, you agree to all of the terms and conditions contained in these Terms, which also incorporate Juju's Privacy Policy, Community Guidelines and all other operating rules, policies and procedures that we may publish from time to time on the Juju Platform, each of which may be updated by Juju from time to time without notice to you in accordance with the terms set out under the "Updates to These Terms" section below. Because Juju also involves multiplayer games, as a user, you are part of a community that must abide by our rules (including these Terms of Use) to create a safe and fun environment. These Terms of Use include some of the rules we expect everyone to follow and we always reserve the right to suspend or terminate your right to access and use Juju for any reason and at any time, in our sole and absolute discretion.

The Juju Platform is a mobile social gaming application that enables people to meet new friends. It is not a dating app and is not intended to be used as a matchmaking service.

# 1. Registering to Play; Creating your Account

When you register and sign up to play games on Juju, you will also have access to a wide variety of promotions, opportunities and, we hope, fun experiences that give you an opportunity to test your skill, earn Juju's in-app virtual currency ("Gems") and even

real-world prizes. When you register, you will be asked to enter some information about you, which may include your name, birth date, e-mail address, and in some cases, payment information. You will log in via Apple Sign in or Snap Login, and shall then be given or afforded the opportunity to create a unique user name (an "ID") that you will use to gain access to Juju each time you return. We will also create a registered user account for you to keep track of the gems you may earn by playing games on Juju (the "Gems"), as described in more detail below under "Gems". Until you redeem, use or otherwise obtain possession of a reward, prize or other real world, non-virtual item in connection with your redemption or award resulting from your use or play in Juju or its related features, functions and promotions, these points and Gems have no value nor any use for any other purpose, other than in the Juju environment and only for as long as you are authorized to access and use Juju and your account.

We may also allow you to register and create an account, access and use Juju through certain social networks or third party proprietary platforms, including Snapchat and Apple, some of which also require you to have an account, and to use the mobile "app" version of Juju, you will also need an account with the wireless or cellular carrier. It is your responsibility to keep the software and "app" in each case, up to date and current or you may find you are not able to access or use Juju. If there are charges or fees for the equipment, "apps," your account or use of these other networks, platforms, carriers and/or services, that is solely your responsibility and not ours. Some carriers have usage-based charges and if you access or use . through a mobile, wireless or cellular service, you should be aware of the charges that may apply. In addition, if you access . through or from a social network or through a proprietary platform of any third party, you also have an obligation to comply with their terms and conditions which apply to the access and use of their network or platform.

By registering and using Juju and your account, you are agreeing that we may notify you by posting something on <a href="www.getjujuapp.com">www.getjujuapp.com</a> or within the Juju games that you may be playing or the features, functions or promotions you are using or participating in, by sending you an e-mail to the address you provide us and, if you provide us with a mobile number, we may send you a text (SMS) message, unless you tell us to STOP. If you provide us with other contact information when you register or at any time in your profile or any communications with us, we may also respond or use that mechanism to contact you.

In addition, some games and services offered through the Services may be subject to additional terms and conditions specified by Juju from time to time; your use of such services is subject to those additional terms and conditions, which are incorporated into these Terms by reference. These Terms apply to all users of the Services. IF YOU DO NOT AGREE WITH THESE TERMS, PLEASE DO NOT USE THESE SERVICES.

ARBITRATION NOTICE. Except for certain kinds of disputes described in clause 17, you agree that disputes arising under these Terms will be resolved by binding, individual arbitration, and BY ACCEPTING THESE TERMS, YOU AND JUJU ARE EACH WAIVING

THE RIGHT TO A TRIAL BY JURY OR TO PARTICIPATE IN ANY CLASS ACTION OR REPRESENTATIVE PROCEEDING. YOU AGREE TO GIVE UP YOUR RIGHT TO GO TO COURT to assert or defend your rights under this contract (except for matters that may be taken to small claims court). Your rights will be determined by a NEUTRAL ARBITRATOR and NOT a judge or jury. (See clause 17)

# 2. Who Can Use the Juju Platform

The games hosted on Juju are free to play and there is never an obligation to purchase anything to play, purchase Gems or participate in any rewards program. As such, we reserve the right, in our sole and absolute discretion, to suspend, revise Juju from time to time or even to discontinue or terminate Juju entirely at any time. We also have the right, at any time and from time to time, in our sole and absolute discretion, to modify, amend or change these Terms of Use.

You may browse the Juju Site and view content without registering or purchasing a subscription, but as a condition to using certain aspects of the Services, including playing any Juju games or connecting with other users of Juju, you are required to register with Juju and represent, warrant and covenant that you provide Juju with accurate and complete registration information (including, but not limited to Snapchat display name, user name ("User Name"), e-mail address and/or mobile telephone number, profile name, picture and a password you will use to access the Services) and to keep your registration information accurate and up-to-date. Failure to do so shall constitute a breach of these Terms, which may result in immediate termination of your Juju account. We recommend, but do not require, that you use your own name as your User Name so your friends can recognize you more easily.

Juju will have the right to use your registration information in connection with servicing and operating the Juju Platform. You agree (i) to restrict access by any other person or entity to your password or other login information, (ii) to not knowingly use the name or email of any other person without authorization, (iii) to not use an email or profile name that is profane, offensive or otherwise inappropriate, (iv) to not allow any third party to use your login information, registration information or User account, and (v) to notify Juju of any breach of security by promptly sending Juju an e-mail to support@getjujuapp.com. You agree that you will be liable for all activities that occur under your User account, even if such activities were not committed by you. Juju is not responsible for any loss or damage as a result of someone else using your User account, registration information or password with or without your knowledge. You acknowledge and agree that certain User account information (such as your account profile name and/or picture) that you provide in connection with the registration of your account will be publicly viewable by all Users of the Juju Platform.

We want our Service to be as open and inclusive as possible, but we also want it to be safe, secure, and in accordance with the law. So, we need you to commit to a few

restrictions in order to be part of the Juju community.

THE SERVICES ARE NOT FOR PERSONS UNDER THE AGE OF 13 OR FOR ANY USERS PREVIOUSLY SUSPENDED OR REMOVED FROM THE SERVICES BY JUJU. IF YOU ARE UNDER 13 YEARS OF AGE, THEN YOU MUST NOT USE OR ACCESS THE SERVICES AT ANY TIME OR IN ANY MANNER. Furthermore, by using the Services, you affirm that either you are at least 18 years of age or have been authorized to use the Services by your parent or legal guardian who is at least 18 years of age and entered into these Terms on your behalf. If you are using the Services on behalf of an entity, then you represent and warrant that you have the authority to bind that entity or organization to these Terms and you agree to be bound by these Terms on behalf of that entity or organization.

In addition, you must not be prohibited from receiving any aspect of our Services under applicable laws or engaging in payments related to the Services. For example, you must not be a convicted sex offender or on an applicable denied party listing.

Juju complies with all applicable laws, including those pertaining to the protection of minors. We do not permit the Juju app to be used to publish, submit/receive, upload/download, post, use, copy or otherwise produce, transmit, distribute or store child pornography or content otherwise depicting child exploitation.

We have zero tolerance for predatory behavior on Juju, and we will report any discovered violation of the prohibition on child pornography or other instances of child exploitation to the National Center for Missing and Exploited Children, who works with global law enforcement agencies to investigate such unlawful behavior. We will also take steps to remove child pornography or content otherwise depicting child exploitation (or otherwise block access to the content determined to contain child pornography or exploitation) from the Juju Platform. Suspected violations of this prohibition may be reported to Juju at the following e-mail address: support@getjujuapp.com. Finally, you may not access, register or use Juju if any laws, regulations, ordinances or court orders that apply to you or your right to access, register or use Juju is prohibited, restricted or not legal, for any reason or if you have previously been suspended, disabled, banned, terminated or prohibited from playing any other 9 Count application or game, accessing any 9 Count website or using any 9 Count service for violation of law or any of our policies.

#### 3. Your Rights to Use the Services

As between any User and Juju, Juju retains all right, title and interest in and to the Juju Platform, throughout the world, in perpetuity, including, without limitation, (i) all text, graphics, typefaces, formatting, graphs, designs, editorial content, HTML, look and feel, software, and data, (ii) all business processes, procedures, methods, and techniques used

in the Juju Platform, (iii) all other materials and content uploaded or incorporated into the Juju Platform, including, without limitation, all Juju Platform content (but excluding User Content (defined below), which is owned by the applicable User subject to the User Content license granted to Juju pursuant to these Terms), (iv) all associated trade secret rights and other intellectual property and proprietary rights recognized anywhere in the world; and (v) the coordination, selection, arrangement and enhancement of such intellectual property as a Collective Work under the United States Copyright Act, as amended (collectively, "Juju Platform IP"), and nothing contained herein shall be construed as creating or granting to any User any right, title or interest in and to such Juju Platform IP other than the express license granted therein pursuant to these Terms. Juju Platform IP is protected in all forms, media and technologies now known or hereinafter developed as well as by the domestic and international laws of copyright, trademarks, patents, and other proprietary rights and laws.

You acknowledge and agree that we may generate revenues, increase goodwill or otherwise increase our value from your use of the Services, including, by way of example and not limitation, through the sale of advertising, sponsorships, promotions and usage data, and except as specifically permitted by us in these Terms or in another agreement you enter into with us, you will have no right to share in any such revenue, goodwill or value whatsoever. You further acknowledge that, except as specifically permitted by us in these Terms or in another agreement you enter into with us, you (i) have no right to receive any income or other consideration from any User Content or your use of any musical works, sound recordings or audiovisual clips made available to you on or through the Services, including in any User Content created by you, and (ii) are prohibited from exercising any rights to monetize or obtain consideration from any User Content within the Services or on any third party service (e.g., you cannot claim User Content that has been uploaded to a social media platform such as YouTube for monetization).

Subject to your compliance with these Terms, and any other policies we make available to you from time to time, Juju grants you a personal, worldwide, royalty-free, non-transferable, non-exclusive, revocable, non-sublicensable license to: (a) access and use the Services for your non-commercial use or internal business use, solely as permitted by the tools, products, services, functionalities and/or features of the Juju Platform, subject in all respects to these Terms, and not for redistribution of any kind; (b) download, install and use the Juju Platform on one or more mobile device(s) (e.g. cell phone or tablet), which natively executes an operating system supported by Juju, and that you own or control for your non-commercial use or internal business use; and (c) use products or services offered within the Juju Platform or Site.

You agree that any software that we provide you, including the Juju Platform, may automatically download and install upgrades, updates or other new features and regularly send log information to our servers. You may be able to adjust these automatic downloads through your mobile device settings. These updates and upgrades are designed to improve and enhance our Services and can include bug fixes, enhancements and new modules.

You consent to the installation of such software, including updates and upgrades (and authorize us to deliver such software to you) as part of your use of our Services. You may withdraw consent by ceasing to use the Services.

You may not sell, rent, lease, assign, distribute, copy, modify or host any part of our Services. As well, you may not adapt, merge, make adaptations, translations or derivative works of, disassemble, decompile, reverse compile, attempt to discover the source code or reverse engineer any part of the Services, except to the extent these restrictions are expressly prohibited by applicable law.

# 4. Rights You Give Us

We do not claim ownership of any content you share on Juju, but you grant us a license to use it.

When you establish an account, you have the opportunity to upload one profile photo and to set your username (any such User uploaded content, "User Content"). In the future, we may update the Service to allow for the sharing or uploading of other types of content, such as sound or video recordings, which shall also be deemed User Consent and subject to these Terms.

Nothing is changing about your rights in your content. We do not claim ownership of the User Content that you post on or through the Services.

Instead, when you share, post, or upload content that is covered by intellectual property rights (like a photo) on or in connection with our Services, you hereby grant to us a non-exclusive, royalty-free, transferable, sub-licensable, worldwide license to host, use, distribute, adapt, modify, run, copy, publicly perform or display, publish and translate (consistent with your privacy and application settings). You further grant us a royalty-free license to use your user name, image, voice, and likeness to identify you as the source of any of your User Content; provided, however, that your ability to provide an image, voice, and likeness may be subject to limitations due to age restrictions.

You can end these licenses anytime by deleting your content or account. However, content will continue to appear if you shared it with others and they have not deleted it. Furthermore, you grant us a non-exclusive, royalty-free and fully paid, irrevocable, worldwide license, with the right to grant sublicenses, to: (1) generate anonymized or de-identified information, including game usage and statistics ("Aggregated Statistical Information"); and (2) using your User Content as described in the Privacy Policy.

# 5. Subscriptions

You may also purchase a Juju subscription, which will entitle you to various perks and benefits. A Juju subscription may be purchased in various packages, such as one-month, three-month, or six-month subscriptions. For all mobile subscriptions, payment will be charged to your iTunes or Google account when you confirm your purchase. Your subscription will renew automatically for the same amount of time as your original subscription unless you switch off the auto-renew feature at least 24 hours before the end of your current subscription. This is because your account may be charged for renewal within 24 hours prior to the end of your current subscription period. You can manage your subscription and switch off auto-renewal by accessing your iTunes or Google account settings. You may not cancel your current subscription during the subscription period, although you may cancel automatic renewal at any time. Both Apple and Google facilitate "free trials" of subscription products (such as Juju) for first-time users and we take advantage of that ability. For example, from time to time we may offer a free initial week to first-time Juju subscribers. Eligibility for any such trial is limited to users who have not previously subscribed to Juju, through either a current or prior Juju account. If you are a previous Juju subscriber and try to claim a free trial, you should be aware that Apple or Google may recognize your ineligibility. If so, you may not receive a free trial, but instead may be charged immediately for your first subscription month. This is a feature controlled by the Apple App Store or the Google Play Store, depending on which platform you use for Juju. Purchases of Subscriptions are non-refundable and non-transferable, even if they expire or are discontinued. We may change the purchase price for Subscriptions at any time, as well as the features included in Subscriptions. We reserve the right to stop issuing Subscriptions at any time and to set expiration dates for Subscriptions. Subscriptions may not be redeemed for any sum of money or monetary value. If you delete your account or your account is terminated for any reason, you will lose all unused Subscription time without refund or other compensation.

#### Through-To-The-Audience Rights

All of the rights you grant in your User Content in these Terms are provided on a through-to-the-audience basis, meaning the owners or operators of third party services will not have any separate liability to you or any other third party for User Content posted or used on such third party service via the Services.

# Waiver of Rights to User Content

By posting User Content to or through the Services, you waive any rights to prior inspection or approval of any marketing or promotional materials related to such User Content. You also waive any and all rights of privacy, publicity, or any other rights of a similar nature in connection with your User Content, or any portion thereof. To the extent any moral rights are not transferable or assignable, you hereby waive and agree never to assert any and all moral rights, or to support, maintain or permit any action based on any moral rights that you may have in or with respect to any User Content you post to or through the Services.

To learn more about how we use information, and how to control or delete your content, review the Privacy Policy at <a href="www.getjujuapp.com/privacy">www.getjujuapp.com/privacy</a>. You also represent and warrant that you have all necessary rights to perform the foregoing activities in respect of the User Content (including in respect of User Content that contains personal information), having provided all notices and disclosures, obtained all applicable consents and permissions, or otherwise have all authority, in each case as required by applicable laws, to enable us to perform the Services. If you only own the rights in and to a sound recording, but not to the underlying musical works embodied in such sound recordings, then you must not post such sound recordings to the Juju Platform unless you have all permissions, clearances from, or are authorized by, the owner of any part of the content to submit it to the Juju Platform.

Notwithstanding any other provision in these Terms, you represent and warrant that you will comply with all laws and regulations regarding endorsements or testimonials made by you in any User Content, including that you will (i) make only accurate statements that represent your genuine experience with any product, good or service and (ii) make all required disclosures pursuant to the Federal Trade Commission's ("FTC") Guides Concerning the Use of Endorsements and Testimonials in Advertising, as such guides may be amended from time-to-time by the FTC. # Permission to use your username and profile picture with accounts, ads, and sponsored content

You give us permission to show your username, Snapchat Bitmoji (profile photo), and information about your actions on the Juju Platform (such as games that you play on the Juju Platform and public comments and [messages] you make on the Juju Platform) next to or in connection with accounts, ads, offers, and other sponsored content that you follow or engage with that are displayed on Juju products, without any compensation to you. As with actions on other content and follows of other accounts, actions on sponsored content and follows of sponsored accounts can be seen only by people who have permission to see that content or follow.

While we aren't required to, we may review, screen and delete your User Content and/or user account at any time if we think it may violate these Terms. You are responsible for the User Content that you send through the Services, including for back up of such content.

If you select a username or similar identifier for your account, we may change it if we believe it is appropriate or necessary (for example, if it infringes someone's intellectual property or impersonates another user).

We're always happy to hear from you but if you volunteer any feedback or suggestions about Juju or the Services, you agree that you will not submit to us any feedback or suggestions that you consider to be confidential or proprietary and that we can use your feedback and suggestions in any manner we deem is appropriate without compensating you.

You acknowledge and agree that Juju may establish general practices and limits concerning use of the Juju Platform, including without limitation the maximum number of days that User Content posted to the Juju Platform will be retained by, or made available through, the Juju Platform, and the maximum storage space that will be allotted on Juju's servers on your behalf. You agree that Juju has no responsibility or liability for the blocking, deletion or failure to store any User Content maintained or transmitted by the Juju Platform. You further acknowledge that Juju reserves the right to change these general practices and limits at any time, in its sole discretion, with or without notice to you.

## 5. Rules of Play

By playing and engaging in activities on our Website, including playing and winning games on the Juju Platform, you have the opportunity to earn Gems. There is no charge at all for this and the more you play or participate in activities described from time to time on our website, the more Gems you can accumulate. To acquire more Gems, you can simply play games on Juju and win Gems from other players, you can play other games or you can buy Gems from us, although there is no requirement that you spend any money at all to play and only the Gems you actually earn or purchase during your game play will be counted towards achieving prize levels or award, if any.

Our users based in the United States may also be able to redeem Gems for real-world prizes that we make available from time to time. There is no charge or fee to accumulate points – they are given to you based on playing the games on Juju Platform in amounts we determine and apply to all our users. Simply look for our redemption center in our website and if you have enough Gems, and are a user based in the United States, use them to redeem a prize. We'll subtract the Gems from your account and get your Prize as soon as we can – often immediately and digitally. At this point, in order to ensure there are sufficient prizes available, we limit each user to earning one prize.

Although Gems have no cash or other value, by playing Juju, you can earn Gems through winning the game play against other players or in other games we may make available from time to time. All Gems you earn or purchase in the game play will count towards your standing on our "leaderboard."

We will keep a leaderboard for each game category we establish from time to time to display the top Gem earners in such categories. At our discretion, we may set Gem-standing criteria for each prize from time to time and decide if and when to award prizes based on the top user on the leaderboard (e.g., the top Gem earner at the end of

this week will be awarded a flat screen television; the three top chip earners at 23:59:59 p.m. GMT will be awarded US\$25 gift certificates, etc.). Play Juju games, earn Gems, meet the criteria and you will be eligible for any prize we elect to award – of course, to actually receive the prize you can't already have received a price, be ineligible to have played or earned Gems, or be legally not permitted to receive the prize we want to award you. If that happens, you will be disqualified and the next user on the leaderboard will be contacted and, if eligible, will be awarded the prize.

Any more detailed rules or opportunities to obtain Gems will be posted on our website and we intend to run promotions and provide our users with new opportunities to get Gems and gather points to keep the games on Juju interesting, engaging and fun for all. Remember, you don't have to spend any money to enjoy our games or gather Gems that you can redeem for valuable rewards – it's just our way of thanking you for your loyalty to Juju.

No scheme or attempt to circumvent the normal procedures in place to individually earn Gems through normal game play or purchase Gems, including any scheme or attempt to automate or the acquisition of Gems via any machine, robotic or automatically generated entries, are permitted. If you attempt to manipulate or tamper with the conduct or operation of any game, or to obtain more than the permitted number of entries in a manner not specifically authorized or permitted by these Terms of Use or the official rules of any game or promotion (e.g., using different phone numbers or email addresses, identities, registrations, logins or any other methods) you will be disqualified and your entries voided and may also subject you to civil or criminal prosecution.

#### 6. Additional Terms regarding Gems

You may earn or purchase Juju's Gems, which may be used solely to acquire prizes offered in the Juju platform from time to time. Gems are not real money, do not have monetary value, and may never be redeemed for "real world" money, or other items of monetary value from outside the Services without our written permission. We may change the purchase price for Gems at any time, as well as the ways you can use Gems. While we may use terms like "earn", "trade-in", or "cash-out" in reference to the Gems, we do so only for convenience and such terms in no way indicate that Gems have monetary value or are real money. You acknowledge that Gems are not real currency and are not redeemable for any sum of money from us at any time. We make no guarantee as to the nature, quality, or value of the features of the Services or any third-party good or services that will be accessible through the use of Gems, or the availability or supply of Gems. Gems obtained via the Services via purchases or other means are provided to you under a limited, personal, revocable, non-transferable, non-sublicensable license to use within the Services.

Gems may not be transferred to other accounts or resold in any manner, including, without limitation, by means of any direct sale or auction service. You have no property interest,

right or title in or to any Gems appearing or originating in the Services or any other attributes associated with use of the Services. Any "virtual currency" balance shown in your account does not constitute a real-world balance or reflect any stored value, but instead constitutes a measurement of the extent of your license. We won't recognize any transfers as legitimate and we may suspend or terminate your account if you attempt to do any of these things. You are not allowed to sublicense, trade, sell or attempt to sell in-game items for "real" money, or exchange these items for value of any kind outside of a game. Any such transfer or attempted transfer is prohibited and void, and we may terminate your account (and reverse any such transfer in our sole discretion) if you attempt to do so, whether or not your attempt is or is not successful.

All Gems are forfeited if your account or access to the Services is terminated or suspended for any reason, in our sole and absolute discretion, or if we discontinue availability of some or all of the Services. We may at any time expire free or promotional Gems given to you.

We have no liability for hacking or loss of your Gems or any goods or services obtained using Gems. We have no obligation to, and will not, reimburse you for any Gems that are lost due to your violation of these Terms. We reserve the right, without prior notification, to limit the quantity of Gems and to refuse to provide you with any Gems. Price, exchangeability and availability of Gems are determined by us in our sole discretion and are subject to change without notice. You agree that we have the absolute right to manage, distribute, regulate, control, modify, or eliminate Gems as we see fit in our sole discretion, and that we will have no liability for exercising such right.

You agree that under no circumstances are we liable to you for any damages or claims that may arise from the loss or use of your Gems regardless of the circumstances. You absolve us of any responsibility to maintain or update your account Gems balance. However, if there is a loss of Gems in your account due to technical or operational problems with the Services, we will refund the lost Gems once the loss has been verified. Without limiting any of the foregoing, our maximum liability or responsibility to you is to refund the Gems lost.

As noted above, you may from time to time be presented with opportunities to redeem Gems, including for prizes offered through the Juju Platform. We will, in our sole discretion, determine and communicate the availability and exchange rate for any Gems, which may be modified at any time. We reserve the right to cancel, restrict or terminate Gems at any time for any reason. All redemptions are subject to these Terms and all limitations and requirements stated via the Services. All acquisitions and redemptions of Gems are final. Once Gems have been lost or spent, they will be subtracted from your account and cannot be refunded or returned, except in our sole discretion.

## 7. Privacy

We encourage you to read it carefully because by using our Services you agree that Juju can collect, use and share your information in the ways described in that policy.

# 8. Safety and Respecting the Rights of Others

Arbitrators can award the same damages and relief that a court can award. This agreement to arbitrate disputes includes all claims arising out of or relating to any aspect of these Terms, whether based in contract, tort, statute, fraud, misrepresentation, or any other legal theory, and regardless of whether a claim arises during or after the termination of these Terms. A party who intends to seek arbitration must first send a written notice of the dispute to the other party by certified U.S. Mail or by Federal Express (signature required) or, only if that other party has not provided a current physical address, then by electronic mail ("Notice of Arbitration"). Juju's address for Notice is: 9 Count, Inc., 517 Victoria Ave., Santa Monica, CA 90291. The Notice of Arbitration must: (a) describe the nature and basis of the claim or dispute; and (b) set forth the specific relief sought ("Demand"). The parties will make good faith efforts to resolve the claim directly, but if the parties do not reach an agreement to do so within 30 days after the Notice of Arbitration is received, you or Juju may commence an arbitration proceeding. All arbitration proceedings between the parties will be confidential

unless otherwise agreed by the parties in writing. During the arbitration, the amount of any settlement offer made by you or Juju must not be disclosed to the arbitrator until after the arbitrator makes a final decision and award, if any. If the arbitrator awards you an amount higher than the last written settlement amount offered by Juju in settlement of the dispute prior to the award, Juju will pay to you the higher of: (i) the amount awarded by the arbitrator; or (ii) \$10,000.

If you commence arbitration in accordance with these Terms, Juju will reimburse you for your payment of the filing fee, unless your claim is for more than \$10,000, in which case the payment of any fees will be decided by the AAA Rules. Any arbitration hearing will take place at a location to be agreed upon in Los Angeles, CA, but if the claim is for \$10,000 or less, you may choose whether the arbitration will be conducted: (a) solely on the basis of documents submitted to the arbitrator; (b) through a non-appearance based telephone hearing; or (c) by an in-person hearing as established by the AAA Rules in the county (or parish) of your billing address. If the arbitrator finds that either the substance of your claim or the relief sought in the Demand is frivolous or brought for an improper purpose (as measured by the standards set forth in Federal Rule of Civil Procedure 11(b)), then the payment of all fees will be governed by the AAA Rules. In that case, you agree to reimburse Juju for all monies previously disbursed by it that are otherwise your obligation to pay under the AAA Rules. Regardless of the manner in which the arbitration is conducted, the arbitrator must issue a reasoned written decision sufficient to explain the essential findings and conclusions on which the decision and award, if any, are based. The arbitrator may make rulings and resolve disputes as to the payment and reimbursement of fees or expenses at any time during the proceeding and upon request from either party made within 14 days of the arbitrator's ruling on the merits.

YOU AND JUJU AGREE THAT EACH MAY BRING CLAIMS AGAINST THE OTHER ONLY IN YOUR OR ITS INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. Further, unless both you and Juju agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.

If Juju makes any future change to this arbitration provision, other than a change to Juju's address for Notice of Arbitration, you may reject the change by sending us written notice within 30 days of the change to Juju's address for Notice of Arbitration, in which case your account with Juju will be immediately terminated and this arbitration provision, as in effect immediately prior to the changes you rejected will survive.

If this Section 16 is found to be unenforceable, or if Juju receives an Opt-Out Notice from you, then the entirety of this Section 16 will be null and void and, in that case, the exclusive jurisdiction and venue described in Section 18 will govern any action arising out of or related to these Terms.

# 18. Severability

If any part of these Terms is found to be invalid, illegal or unenforceable for any reason, then that provision will be severed from these Terms to the minimum extent such that the remaining provisions of these Terms will continue in full force and effect.
